OVERVIEW — The *Ella Victoria Dobbs Award* is presented in recognition of unique or outstanding published research conducted by a Pi Lambda Thetan. The award was established in 1965. It is sustained by a restricted fund established in the Pi Lambda Theta Educational Endowment pursuant to a bequest from Ella Victoria Dobbs. Dobbs was instrumental in founding Pi Lambda Theta and served as president from 1921 to 1925.

AWARD — The award consists of a cash payment of four hundred dollars (\$400) and a framed certificate.

NOMINEE CRITERIA — A nominee must be a member of Pi Lambda Theta. A nomination must include evidence that the qualifying research was published within the two calendar years immediately preceding the council. [Research may be in the form of books, articles, theses, or dissertations.]

NOMINATION REQUIREMENTS — A nomination must be made by a member in good standing or by a non-member with the endorsement of a member in good standing. **Self-nomination/endorsement is not permitted.** A complete nomination includes:

1. a Pi Lambda Theta universal application/nomination cover sheet
2. a sample of the qualifying research

To the extent possible, letters of support should specifically address the nomination criteria. No additional copies of the above material are required for a complete nomination; however, Pi Lambda Theta reserves the right to require up to 10 copies of material that is not readily reproducible or that is unusually long.

SELECTION — Recipients are selected by Pi Lambda Theta's founding chapters, which rotate the responsibility of determining the recipient. The responsible chapter may, at its discretion, decide not to make the award.

SUBMISSION — The complete nomination must be *received* in the Pi Lambda Theta international office by the deadline below. Send nominations to:
